- b. for the purpose of making perfect ambiances in education, and dissemination of knowledge, to establish schools-primary and secondary, (as warrant for any scheme under Matriculation Board, CBSE or/and any other scheme as permissible by Education Authorities) Colleges and such of those educational institutions. And such institution shall be run without the motive of profit.
- c. to make the poor, needy and destitute students in education cope with good performance by inculcating in them the great potential they do have, by providing them the necessary inputs-conduction of workshops, providing needful infrastructure, monetary benefits and c.
- d. to make measures and to educate the public keep their environments clean and tidy and teach them the importance of good health habits.
- e. to enable make a situation to eradicate child labour and retreat them to the social fabric by offering means for education with educational paraphernalia with subsidized rate or freely in such of those desired cases.
- f. to render help and assistance in cash or in cash's worth of kind to poor and destitute persons or widows & c. to cope in their social life, with the perfect and different thinking of adage, '*survival of the fittest in one of the ways to survive, but it is not a way of life.*'
- g. to foster and encourage education and training in handicrafts, fine arts among women folks in general and establish institutions importing such education and to establish support or help by monetary gifts or otherwise through institution established for this purpose, for women and children and to provide them social welfare.
- h. to grant or give scholarship or/and loans, stipends, prizes, rewards and other financial assistance to students in pursuing their studies in schools, colleges, technical institutions art schools or other training, research or educational works in India.
- i. to publish books, pamphlets, periodicals and newspapers in India to disseminate and advancement of education and good social culture among the students and the general public.
- j. to start, run, assist social programmes who get caught in the backward community women, children, bonded labour and other sections of the society for the promotion in legal assistance, legal awareness, training of para legals, human rights, civil rights and other matters concerned with overall development of those sections of the society.
- k. to run/conduct workshop, programme, seminars, etc., for the educated unemployed and the rural youth in co-ordination with other organizations.
- l. to promote and foster education among poor and deserving students, whether of primary, secondary, graduate, post-graduate or vocational courses by all means and make such education available to weaker sections of the community.
- m. to institute and distribute scholarships to poor and deserving students enabling them to seek higher studies and to give grants for fees and other charges or distribute free of cost books, instruments and other educational aids for their educational pursuits.

- n. to organize, start, run or assist any programme either by itself or by assisting or co-ordinating with other educational or other institutions for coaching, guidance and counseling, vocational training or training for preparation for any entrance or competitive tests for recruitment for jobs across India and state service examination or and such type of job-yielding competitive examination for admission to professional or other educational institutions.
- o. to run, develop or improve conditions/developing infrastructure in any existing school, college or other educational institution or adopt, assist or help any existing educational institution without profit motive for the benefit of the public across India in general and more particularly for the benefit of those who lack in these social / educational facilities.
- p. to run computer training centres. And to give paraphernalia as to those who get training in computer education and further provide impetus in such present electronic world, which plays a pivotal role through different social electronic media.
- q. to give, donations to educational institutions which are run on non-profit basis subject to such conditions consistent with the objects of the Trust.
- r. to help establishment of students' hostel or to give other assistance for poor and deserving students to find inexpensive living accommodation to enable them to pursue their studies.
- s. to distribute prizes for outstanding achievements of students in educational institutions either in the examinations, sports, general knowledge or such other proficiencies.
- t. to undertake these and other incidental activities without profit motive which are consistent with the above objects and are not inconsistent with the object of the trust being promotion of education.
- u. to allocate funds, either monetary or other forms for the purposes of education in pursuance of the above objects will be confined to Indian shores.
- v. if any of the above objects is found to be inconsistent with the objects of public educational charitable institution under section 10[22] or any other section of the Income-tax Act, 1961 or any other law applicable to such trusts as now enacted or as may be enacted or amended at a future date, the objects stated above will be treated as so modified to accord with such law or amended law so that any concessions, privileges, conditions or regulations available and applicable to public educational institutions will be available or applicable to this Trust as well so that this institution will continue to retain its character as a public educational institution without profit motive with public character within the meaning of section 10[22] of the Income-tax Act, 1961 or any other analogous provisions under the Income-tax Act or any other law.

3. The subsidiary objects of the Trust are as follows :

- a) to form or enable a group to form among them Self Help Group (SHG) comprising of Individuals, separate SHGs for different sex shall be formed and each SHG whose objective is to improve social fabric among themselves. Each SHG shall be formed with a specific/multiple societal objects in the area in which it will be formed. Formulation and guidance and in case any other help shall be needed by SHG for the purposive functioning of such SHG, the trust hereby created shall extend. Such SHG shall function for the benefit of the members as a whole.

- b) to establish, maintain or grant aid for the establishment or maintenance of bore well or sunk wells, tube wells, water reservoirs and trees and construction and repair of paths, roads, bridges etc., for the use of the general public.
- c) the trustees may at any time invite and receive or without such invitations receive any voluntary contributions from any person or persons whatsoever by way of donation or annual or other subscription or legacy or otherwise for the support as for the benefit of the trust hereby constituted.
- d) to develop a healthy as well as critical attitude towards the development of mental, physical and moral uplift of the members belonging to any of above said SHGs and those connected with those members of the group (SHG) so as to make them good citizens.
- e) to train and equip the members and the public so as to make them aware of ways and means to become self-supportive in a honourable and decent way of live so as to develop into good, healthy and progressive citizens.
- f) to promote, assist and maintain all activities by whosoever carried out or whenever carried out in India in conformity with the objects of the trust and as are conducive to the well being and general welfare of the nation or for advancement of any object of general public utility not carrying on any activity for profit.
- g) the objects either of mentioned as main, under clause 2) and 3) above shall be kept within the boundaries of India and the functionalities of the Trust shall strictly be kept within India alone.

It will be open to the Board to co-opt other trustees by consensus, so, however, the total number of the trustees at no time shall exceed eleven. In the event of any trustee vacating his/her office for any reason whatsoever, the Trust Board may continue without such persons, so however the number of trustees will not get reduced below 3 at any point of time. If it happens to fall below 3, the vacancy will be filled up forthwith by appointing like needed as Trustees by the consensus of the remaining Trustees.

5. Trust Fund/Trust Board/ Trustees/s :

a) Trust Fund :

The trust fund will contain the initial corpus as stated herein and also any funds, contribution by well-wishers, institutions and other voluntary agencies, subscriptions from participants received for the furtherance of the objects upon such terms and conditions as the trustees may at their absolute discretion accept such contributions, as long as they are not inconsistent with the objects of the trust.

b) Board of Trustees :

All trustees collectively will form the Board of Trustees though they individually be called as Founder, Member Trustee and Managing Trustee who will meet monthly or as often as required with a week's notice. Resolution on urgent matters can be passed by circulation and recorded in the minutes of next meeting. Minutes will be kept for each meeting and signed by the Managing Trustee. The Board will be presided by the Managing Trustee in and her absence by the other Trustee elder in age. Decisions will be taken by the majority where there is no consensus.

c) Trustee/Trustees :

Trustee/Trustees used in this indenture mean in singular any single trustee authorized by the Board of Trustees and Trustees in plural would refer the Board collectively.

6. Power of Trustee(s) :

- a) The Managing Trustee shall have powers to invest the corpus funds and its income pending use for the objects of the trust only in those investments permitted for public charitable institutions under any law governing public trust either of the State, local or Central Government and more particularly under section 11(5) of the Income-tax Act and analogous provisions of the direct tax laws now or as may be amended from time to time.
- b) The Managing Trustee consistent with the foregoing objects, powers and restrictions the Managing Trustee may make such arrangements, draw up such schemes and frame such rules, regulations or bye-laws as he or they shall in his/her/their uncontrolled discretion think fit for the administration of the trust hereby constituted and may amend, alter or repeal any of the said arrangements, schemes or rules as may be considered necessary consistent with the objects of the trust.

7. Accounts :

The Managing Trustee shall cause a true and accurate accounts to be kept of moneys received and spent and of all matters in respect thereof in course of management of trust properties or in relation to the carrying out of the objects and purposes of the trust as well as of all the assets, credits and effects of the trust properties. Accounts shall be closed on the 31st March every year and audited by 30th September following by the person qualified to audit who is a Chartered Accountant within the meaning of The Chartered Accountants Act 1949 read with the Chartered Accountant Regulation 1988, as amended from time to time.

8. Power to sue :

The Managing Trustee or the Trustee/s shall be entitled to sue by the name of the trust and may similarly be sued in the name of the trust.

9. Duration of the trust :

The trust is irrevocable and will continue in perpetuity.

10. Amendment to the trust :

It will not be open to the trustee/s to amend the objects or the terms stipulated in this indenture. If any amendment is necessary for more effective implementation of the objects, it may be made subject to the concurrence of the Commissioner of Income-tax/Chief Commissioner of Income-tax/Director of Exemptions or any other concerned authority under direct tax laws in order that the trust may continue to have the status of a public educational institution under section 10(22) and 10(22A) of the Income-tax Act or as a public charitable institution under section 11 or the Income-tax Act or any analogous sections under similar other laws, now or as may be amended from time to time. The powers to effect any amendment to the Trust Deed by the trustees, such powers should not extend to alter the basic character/objects of the trust. No amendment which may prove to be repugnant to the provisions of Sec.2(15) 11, and 13 and Sec.80G of the Income-tax Act, shall be made and further such amendments which would extend to alter the basic character/objects of the Trust shall not be allowed.

11. Functions :

Without affecting the generality of powers and functions of the trustee/s to manage and administer the trust, the trustees collectively or the Managing Trustee individually for and on behalf the Trust shall have the following functions:

- i. to borrow if need be against the security of the assets of the trust by way of bank overdraft, loan or otherwise, as may be necessary, for the benefit of the trust and for more effectively carrying out the objects and to bind the trust property for the purposes and enter into any agreement and sign such document as the Managing Trustee is authorized by the Board of trustees to execute such documents, deeds, papers, etc., as may be necessary in connection therewith.
- ii. to arrange for and/or authorize the signing of or execution of any agreement, contract, instrument, document or any other paper or writing required to be signed or executed on behalf of the trustee/s Managing Trustee by the trustee or any two of the trustees to be nominated in this behalf by a resolution at the meeting of the Board of Trustees and to make the same effective and binding as if the said agreement, contract, instrument or document or paper or writing were signed by all the trustees.
- iii. to appoint or make provision for the appointment of a subcommittee of members from outside the Board of Trustee and/or others to attend to or supervise or conduct specified jobs or functions or entrust matters in such manner and subject to such rules and regulations as the trustees may prescribe.
- iv. to authorize any one or more trustees to hold any property or any fund or any investment of the trust subject however to the terms of these presents in such manner and subject to such terms and conditions, rules and regulations as trustee/s may from time to time think fit and proper.
- v. to spend any portion of the corpus or the income of the trust for purchasing any land and/or constructing any building or buildings for and in the name of the trust for the purpose of carrying out, promoting and/or executing any or all of the objects of the trust.

12. Other incidental powers :

- i. The Managing Trustee individually or the Trustees collectively may invest the Trust funds either in immovable properties or in such manner as prescribed by these presents and as allowed by law as may be in force from time to time and to convert, alter, vary, dispose of or transfer such investments from time to time for better being able to conduct the affairs of the trust consistent with the objects of the trust.

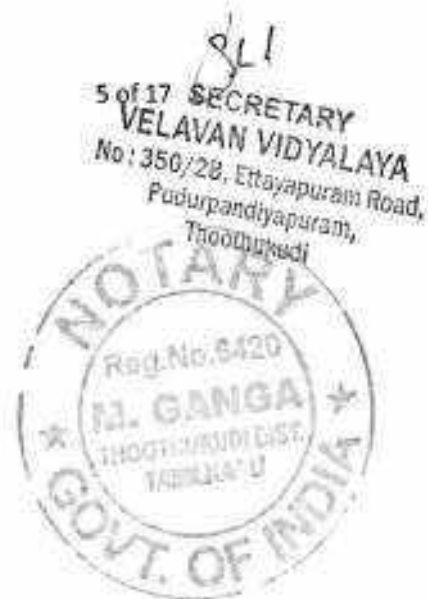

- e. to enable make a situation to eradicate child labour and retreat them to the social fabric b offering means for education with educational paraphernalia with subsidized rate or freely in such of those desired cases.
- f. to render help and assistance in cash or in cash's worth of kind to poor and destitute persons or widows & c. to cope in their social life, with the perfect and different thinking of adage, 'survival of the fittest in one of the ways to survive, but it is not a way of life.'
- g. To foster and encourage education and training in handicrafts, fine arts among women folks in general and establish institutions importing such education and to establish, support or help by monetary gifts or otherwise through institution established for this purpose, for women and children and to provide them social welfare.
- h. to grant or give scholarship or/and loans, stipends, prizes, rewards and other financial assistance to students in pursuing their studies in schools, colleges, technical institutions art schools or other training, research or educational works in India.
- i. to publish books, pamphlets, periodicals and newspapers in India to disseminate and advancement of education and good social culture among the students and the general public.
- j. to start, run, assist social programs who get caught in the backward community women, children, bonded labour and other sections of the society for the promotion in legal assistance, legal awareness, training of para legals, human rights, civil rights and other matters concerned with overall development of those sections of the society.
- k. to run/conduct workshop, programme, seminars, etc., for the educated unemployed and the rural youth in co-ordination with other organizations.
- l. to promote and foster education among poor and deserving students, whether of primary, secondary, graduate, post-graduate or vocational courses by all means and make such education available to weaker sections of the community.
- m. to institute and distribute scholarships to poor and deserving students enabling them to seek higher studies and to give grants for fees and other charges or distribute free of cost books, instruments and other educational aids for their educational pursuits.

- n. to organize, start, run or assist any programme either by itself or by assisting or co-ordinating with other institutions for coaching, guidance and counseling, vocational training or training for preparation for any entrance or competitive tests for recruitment for jobs across india and state service examination or and such type of job-yielding competitive examination for admission to professional or other educational competitive examination for admission to professional or other educational institutions.

3. The subsidiary objects of the Trust are as follows:

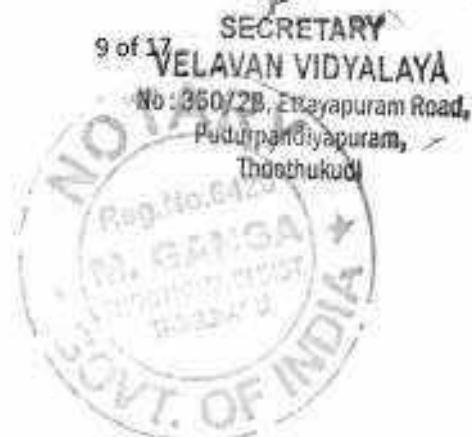

5. Trust Fund/Trust Board/Trustees/s:

6. Power of Trustee(s):

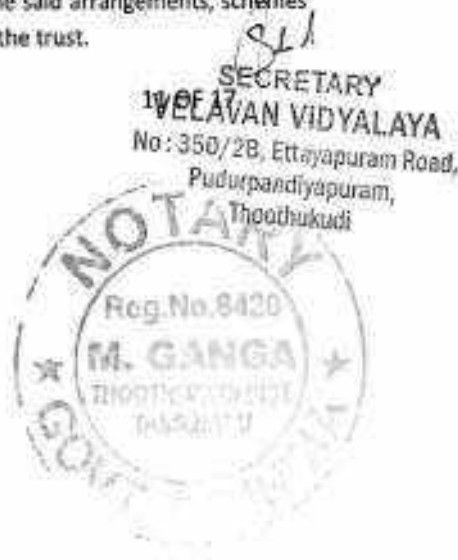

7. Accounts:

11. Functions:

- iv To authorize any one or more trustees to hold any property or any fund or any investment of the trust subject however to the terms of these presents in such manner and subject to such terms and conditions, rules and regulations as trustee/s may from time to time think fit and proper.
- v To spend any portion of the corpus or the income of the trust for purchasing any land and/or constructing any building or buildings for and in the name of the trust for the purpose of carrying out, promoting and/or executing any or all of the objects of the trust.

12. Other incidental powers:

- ii. If the income from the trust property in a particular year is not fully utilized, the unexpended income subject to the applicable provisions of the Income-tax Act, 1961 as may be amended from time to time or under any provision of Trust law or regulations governing such charitable institutions shall be carried over to the next year or years and spent in such subsequent year or years for the advancement of any of the object of the trust, the money meanwhile will be invested in the manner required or permitted by the above said laws.

- vii.
